

ROBBINSDALE CITY COUNCIL
WORK SESSION MINUTES

1. The work session was called to order by Mayor Pro Tem Selman at 6:38 p.m.
2. Councilmembers Present: Kline, Webb, Selman, Backen, Mayor Blonigan

DISCUSSION OF BLRT COMMITTEE ASSIGNMENTS

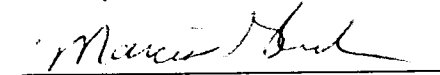
7. Mayor Blonigan indicated that he would like to be the Corridor Management Committee member. Selman was supported to continue as the alternate.

It was agreed that there would be outreach to the community to identify parties interested in applying to be the 2nd CAC member.
