- A. Discuss Lease at 4165 Hubbard Ave

Bruce Glover, a resident at 3355 York Ave N, stepped forward to the podium to speak about his displeasure with the planning process for the Blueline Project being proposed. He said that this form of transportation is extremely costly, non-flexible, slow, and that the proposed space would be better suited for car traffic.
